Berthold

This is a contract between you and Berthold Direct Corp. ("Berthold"). This Agreement grants you certain rights to use the Font Software and is not an agreement for sale of the Font Software or any portion or copy of it. Please read the terms carefully.

Font Software. The font software you selected for purchase (the "Font Software"), is the property of Berthold and/or its suppliers. The term "Font Software" includes any related documentation, updates, permitted modifications and permitted copies of the Font Software licensed to you by Berthold. You agree that Berthold and/or its suppliers own all rights to the Font Software and its structure, organization and code, including copyrights, design and trademark rights. In addition, you agree that the code and structure of the Font Software constitute and contain valuable trade secrets owned by Berthold and/or its suppliers.

Licensed Computers; Copies. Upon payment of the nonrefundable license fee, Berthold grants you a nonexclusive, limited right to use the Font Software on the permitted number of Licensed Computers, and output the Font Software on any output devices connected to such computers, at 1 physical location. Portable computers may be included within the number of permitted Licensed Computers provided that such portable computers are primarily used at the physical location where the other Licensed Computers are located.

The permitted number of Licensed Computers is 5 unless you have obtained a license for additional Licensed Computers (available in increments of 5). For each 5 Licensed Computers, you may also download the Font Software to the memory (hard disk or RAM) of 1 output device connected to 1 such computer for the purpose of having such Font Software remain resident in the output device.

However, if you license the Berthold Exklusiv Collection or the Adobe Berthold Exklusiv Collection, the permitted number of Licensed Computers is 20 unless you have obtained a license for additional Licensed Computers (available in increments of 10). For each 20 Licensed Computers, you may download the Font Software to the memory (hard disk or RAM) of 2 output devices connected to 2 such computers for the purpose of having such font software remain resident in the output devices.

You may not duplicate or copy the Font Software except as needed to use it as expressly permitted by this Agreement. However, you may make 1 copy of the Font Software for backup purposes. All permitted copies you make must contain the exact copyright, trademark and other proprietary notices that appear on and/or in the Font Software.

Modifications. You may modify the Font Software to satisfy your design requirements, but you may not change the name of the Font Software. All modified Font Software is subject to this Agreement and, therefore, all copies must contain the exact copyright, trademark and other proprietary notices that appear on and/or in the Font Software. Except as expressly stated in this paragraph, you agree that you will not modify, adapt, translate, reverse engineer, decompile, decrypt, disassemble nor create derivative works of the Font Software without Berthold's prior, express written consent.

Limited Embedding. You may embed the Font Software into portable document files that you may send to users not covered by this Agreement provided that: (1) such portable document files are for your own noncommercial use (e.g. letters, agreements, invoices, etc.); and (2) the security for the portable document files is set to allow only printing and viewing and to prohibit changing, selecting or adding. Any embedding of the Font Software not expressly described above (e.g. embedding into web pages, documents for widespread or general distribution, etc.) is prohibited by this Agreement and requires an additional license from Berthold.

Transfer; Service Bureaus. You may not rent, lease, sublicense, distribute, lend nor transfer the Font Software, or any portion of the Font Software, without Berthold's prior written consent. You may send a copy of the Font Software, or any portion of the Font Software, used in your documents to a commercial printer or service bureau to enable the editing or printing of your documents, provided that such commercial printer or service bureau has reasonably assured you that it has a valid license to use the Font Software.



No Other Use. You are granted only the rights expressly stated in this Agreement, and you may not use the Font Software for any other use. For the avoidance of doubt, below are examples of uses that are NOT permitted under this Agreement and require purchase of a separate license from Berthold: (1) You may not include the Font Software as part of games, e-books, printers, software, or any other products; (2) You may not share the Font Software with other business entities (e.g. your ad agency, dealer, service bureau, etc.); (3) You may not use the Font Software on more than the permitted number of Licensed Computers; (4) You may not use the Font Software at more than one physical location; (5) You may not change the name of the Font Software; (6) You may not embed the Font Software into your web pages, downloadable manuals, etc.

Termination. This Agreement will immediately and automatically terminate without notice if you fail to comply with any term or condition of this Agreement. Upon termination, you must destroy all copies of the Font Software.

Limited Warranty; No Refunds. For a period of 90 days after delivery, Berthold warrants that the Font Software will perform as outlined in the user documentation in effect at the time of the commencement of this license. Berthold will correct substantial malfunctions occurring during this warranty period provided that such malfunctions are reproducible, your product is properly registered, and you give immediate notice and sufficient detail of such malfunctions to Berthold. Such corrections generally will be incorporated into new revisions of the Font Software, or until the release of such new revisions into temporary versions, at Berthold's discretion. The correction may also be achieved by delivery of new versions of the Font Software in which case the warranty does not cover such additional functionality and performance. Berthold will have no responsibility in the event you fail to provide proof of purchase from authorized Berthold sources.

EXCEPT AS EXPRESSLY PROVIDED IN THE PARAGRAPH ABOVE, THE FONT SOFTWARE IS PROVIDED "AS IS." BERTHOLD AND ITS SUPPLIERS DO NOT MAKE ANY WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE AND NONINFRINGEMENT. The Font Software is nonreturnable and nonrefundable.

Damages Limitations. BERTHOLD'S CUMULATIVE LIABILITY FOR ANY LOSS OR DAMAGE RELATING TO THIS AGREEMENT WILL NOT EXCEED THE PURCHASE PRICE THAT YOU PAID FOR THE FONT SOFTWARE. BERTHOLD WILL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, INDIRECT OR CONSEQUENTIAL DAMAGES, SUCH AS LOST PROFITS OR LOST DATA, WHETHER IN AN ACTION OF CONTRACT, TORT OR OTHERWISE, ARISING OUT OF OR IN CONNECTION WITH THE USE OF, OR INABILITY TO USE, THE FONT SOFTWARE EVEN IF BERTHOLD HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. Because some jurisdictions do not allow the exclusion or limitation of liability for consequential damages, the above limitation may not apply to you.

U.S. Government Restricted Rights. The Font Software is provided with restricted rights. Use, duplication or disclosure by the U.S. Government is subject to the applicable restrictions as set forth in DFARS 252.227-7013(c)(1)(ii) and FAR 52.227-19.

Governing Law. This Agreement is governed by the laws of Illinois, U.S.A. You expressly agree that any disputes related to this Agreement will be resolved by the courts located in Illinois and you consent to personal jurisdiction of those courts. If any part of this Agreement is found void and unenforceable the balance of the Agreement will remain valid and enforceable according to its terms. This Agreement may only be modified by Berthold in a writing that expressly states that such writing is intended to modify this Agreement.
